ABOUT THE MALAYSIAN TECHNICAL COOPERATION PROGRAMME (MTCP)

The Malaysian Technical Cooperation Programme (MTCP) was first initiated at the First Commonwealth Heads of Government Regional Meeting (CHOGRM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the 2nd CHOGRM in New Delhi, India, to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCDC).

In line with the spirit of South-South Cooperation, Malaysia through the MTCP shares its development experiences and expertise with other developing countries. Since its inception in 1980, more than 33,000 participants from 144 recipient countries have benefited from the various programmes offered under the MTCP. ABOUT ENVIRONMENT INSTITUTE OF MALAYSIA (EiMAS)

The Environment Institute of Malaysia (EiMAS) was established in 2001. It is located within the campus of Universiti Kebangsaan Malaysia (UKM), Bangi, Selangor. It is the training institute of the Department of Environment Malaysia (DOE), under the Ministry of Natural Resources and Environment. Training programmes conducted by EiMAS for DOE personnel focus on diverse areas pertaining to environmental management and pollution control such as water quality management; air quality management; environmental legislation and enforcement; scheduled waste management; and environmental impact assessment. APPLICATION

Submitted application forms must be accompanied by the applicant's:

- Copy of Passport
- Passport sized coloured photo (3.5cm x 5cm)
- Medical Report

All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal/Aid Coordinator Agency in the respective countries (the relevant ministry or agency responsible for the overall coordination of international technical assistance) and should be submitted ONLY through the diplomatic channel via Embassy of Malaysia in the respective countries.

Only successful applicants will be notified.

TARGETED PARTICIPANTS

This Course is relevant for middle to senior level official from the Environmental Protection Agency of all MTCP Recipient Countries.

Education and Working Experience

Applicants must:

- i. possess at least a Diploma in the field of sciences or engineering and proficient in English.
- ii. have at least 1-year practical experience in environmental management and pollution control

OTHER INFORMATION

Food and Lodging

Food and lodging will be provided for the duration of the course. Participants are not allowed to bring any family members during the course.

Air Fares

The Government of Malaysia shall provide excursion economy air ticket to all MTCP participants from the capital city of the MTCP recipient country to Kuala Lumpur and return air ticket from Kuala Lumpur to the capital city of the MTCP recipient country.

Course Fees

All course fees are borne by the Government of Malaysia.

Medical and Dental Treatment

Candidates should be certified medically and physically fit to participate in this programme. Medical treatments are provided at government hospitals/clinics only and the expenses will be borne by the Government of Malaysia under the MTCP. In case of an emergency, participants are eligible to be admitted to government hospitals/clinics. Dental treatments are restricted to extraction and filling only.

Visa and Vaccination

It is mandatory for all the MTCP participants to follow the Visa With Reference (VWR) application procedure. Once the approval is obtained, the training institution should send a copy of VDR approval letter to the participants. Subsequently, with the copy of the approval, the participants may get the VDR from the nearest Embassy of Malaysia. Wherever applicable, participants are advised to arrange for vaccination on their own prior to travel to Malaysia.

Expenditures on all visa-related fees, airport tax/airport user's charge, transit insurance, excess luggage, travel tax, transit fees, domestic passenger terminal fees, phone charges, private purchases, etc borne by the participants. This also applies for vaccination before travel to Malaysia.

Participants shall conduct themselves at all times in a manner compatible with their responsibilities as MTCP participants and abide by the laws, rules and regulations. As may be stipulated by the host government in respect of this training course.

Participants are NOT allowed to bring along their spouses or families for the duration of the course. Participants are NOT allowed to plan for their own vacation or go to other destinations during the course duration without prior approval from the training institution. Participants will be required to return to their own countries upon completion of the course.
