

About Malaysian Technical Cooperation Programme (MTCP)

The Malaysian Technical Cooperation Programme (MTCP) initiated at the First Commonwealth Heads of Government Regional Meeting (CHOGRM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the 2nd CHOGRM in New Delhi, India, to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCDC).

In line with the spirit of South-South Cooperation, Malaysia through the MTCP shares its development experiences and expertise with other developing countries. The programme forms part of the commitment of the Malaysian Government towards the promotion of technical cooperation among developing countries, strengthening of regional and sub-regional cooperation, as well as nurturing collective self-reliance among developing countries.

Since its inception in 1980, more than 33,000 participants from 144 recipient countries have benefited from the various programmes offered under the MTCP. More information at MTCP website : www.mtcp.kln.gov.my

NAA is about 55 kilometres from The National Audit Department Headquarters in Putrajaya and 10 kilometres from the Kuala Lumpur International Airport (KLIA). The Academy occupies an area of 20 acres.

The National Audit Department envisages the Academy to be utilized as a platform for enhancing professionalism in public sector auditing. It is entrusted with the responsibility to upgrade and enhance the auditing knowledge, skills and attitude of the auditors through systematic and planned training programmes. It takes into account the requirement for the current training needs and to be prepared for future challenges.

In addition, it also serves to promote awareness within the public sector on the importance of public accountability through courses offered in the fields of auditing, accounting, information and communication technology and management.

All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal Point/Aid Coordinator Agency in the respective countries (the relevant ministry or agency responsible for the overall coordination of international technical assistance) and should be submitted ONLY through the diplomatic channel via Embassy of Malaysia in the respective countries.

Applicants will be notified of their acceptance to the course by the Training Institutions. **Only successful applicants will be notified.**

Submitted application forms must be accompanied by the applicant's:

- ♣ Copy of Passport
- ♣ Passport sized coloured photo (3.5cm x 5cm)
- ♣ Medical Report

- Have at least five (5) years of government auditing experience, preferably in IT environment or planning to initiate such audit in near future.
- Good working knowledge of both spoken and written English since the group requires active participation in group discussion, group & individual exercises.
- Age between **26 to 50** years old.

- Members of **Supreme Audit Institution (SAI)**

SUCCESSFUL PARTICIPANTS

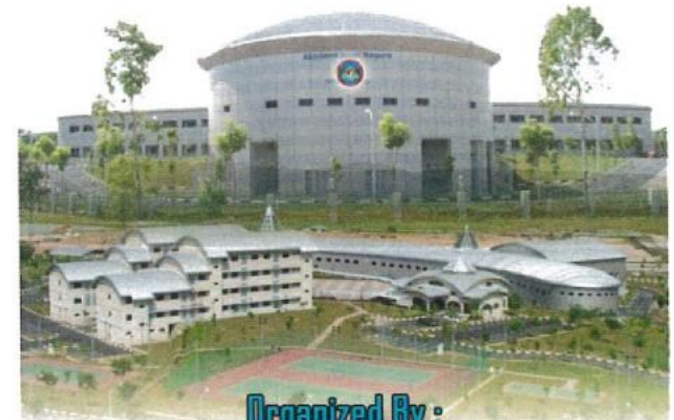
